

**MONONA COUNTY ORDINANCE NO. 46**

**TITLE:** An amendment to the Monona County Zoning and the Official Zoning Maps.

**BE IT ENACTED** by the Board of Supervisors of Monona County, Iowa:

**SECTION 1. Purpose:** This ordinance amends the current Monona County Zoning and Official Zoning Maps for Alliance Production of Iowa, LLC.


**SECTION 2. Amendment:** The Monona County Zoning and Official Zoning Maps shall be amended to reclassify the following described real property from A-1 (Agricultural District) to A-2 (Agribusiness District):

All that part of the Northwest Quarter of the Southwest Quarter (NW ¼ - SW ¼) of Section Thirty (30), Township Eighty-Five (85) North, Range Forty-five (45) West of the Fifth (5<sup>th</sup>) Principal meridian, Monona County, Iowa, described as beginning at the West Quarter (W ¼) corner of Section Thirty (30), Township Eight-five (85), Range Forty-five (45), thence South 89 degrees 45 minutes 15 seconds East along the North line of the Southwest Quarter (SW ¼) of Section Thirty (30), Township Eight-five (85), Range Forty-five (45), 770.00 feet, thence due South parallel with the West line of said Southwest Quarter (SW ¼), 1131.50 feet, thence North 89 degrees 45 minutes 15 seconds West parallel with the North line of said Southwest Quarter (SW ¼), 770.00 feet to the West line of the Southwest Quarter (SW ¼) of Section Thirty (30), Township Eighty-five (85) Range Forty-five (45), thence due North along said West line 1131.50 feet to the point of beginning.

Note: The West line of the Southwest Quarter (SW ¼) of Section Thirty (30), Township Eighty-five (85), Range Forty-five (45) is assumed to bear due North.

**SECTION 3. Ordinance Repealed.** The previously adopted Monona County Zoning and Official Zoning Maps are repealed as said Zoning Maps pertain to the above described real estate.

**SECTION 4. When effective:** This amendment to the Monona County Zoning and Official Zoning Maps should be effective after the final passage, approval and publication as provided by law.

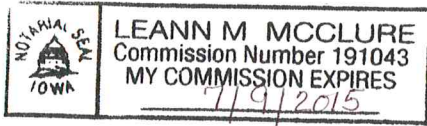
